SUBJECT: Debt Settlement Plan #19-01
Bob Brady for Congress (C00333740)

I. INTRODUCTION

Bob Brady for Congress (“Committee”) wishes to terminate and has filed the attached debt settlement plan for Commission approval. The plan discloses that the Committee owes a debt to one creditor — for legal services — and that the debt has been settled with the creditor. We recommend that the Commission approve the debt settlement plan because it meets all of the regulatory factors the Commission considers in evaluating such plans. As discussed in this memorandum, the Committee did disclose spending \$8,555.74 on vehicle expenses this calendar year even though Mr. Brady left office on January 3, 2019, but such expenses were reported within six months of departure and may have been related to the winding down of his office. Accordingly, we believe that these reported expenses should not prevent the Commission from approving the debt settlement plan.

The debt settlement plan states that the Committee owes \$136,733.39 to the creditor. We note, however, that the correct settlement amount at issue is \$236,733.39. In April 2018, the Committee reported owing \$236,733.39 in legal fees to Dilworth Paxson, LLP, a law firm. Amended 2018 April Quarterly Report (Apr. 19, 2018) at 35, Schedule D. In June 2018, the Committee made a \$100,000 payment to the firm. 2018 July Quarterly Report (Jul. 13, 2018) at 11 (Schedule B). In April 2019, the firm acknowledged in writing that it had accepted the

\$100,000 payment in satisfaction of the full debt. Attachment 1 at 3, 6; Attachment 2. Thus, while the debt settlement plan reports the debt owed to the firm as \$136,733.39, both the Committee and the creditor law firm have represented that the \$100,000 payment has settled the entire \$236,733.39 debt.

II. THE COMMISSION HAS THE AUTHORITY TO ACT ON THIS DEBT SETTLEMENT PLAN

Directive 10 explicitly authorizes the Commission to consider and approve debt settlement plans even when it has fewer than four commissioners. Commission Directive 10, para. L.3.(i); *see also* DSP 07-02, Matt Brown for U. S. Senate (C00409722), Commission Certification (Apr. 28, 2008) (approving a debt settlement plan with an affirmative vote of two commissioners). Accordingly, commissioners may meet, discuss, and vote on this debt settlement plan. Commission Directive 10, para. L.2.&3.(i).

III. THE COMMISSION SHOULD APPROVE THE COMMITTEE'S DEBT SETTLEMENT PLAN

A. The Debt Settlement Plan Meets the Six Factors Under Section 116.7

The Commission reviews debt settlement plans to ensure that neither excessive nor prohibited contributions result from the creation and settlement of a committee's debts. *Debts Owed By Candidates and Political Committees*, 55 Fed. Reg. 26378 (Jun. 27, 1990). The Commission considers six factors in evaluating debt settlement plans: (1) information provided by the Committee and its creditors; (2) the amount of each debt that remains unpaid and the length of time each debt has been overdue; (3) the amount and percentage of each debt that would be forgiven under the plan; (4) the total amount of debts and obligations owed by the terminating committee to all creditors, compared to the total amount of cash on hand and other amounts available to pay those debts and obligations; (5) the year-to-date expenditures and receipts of the terminating committee; and (6) whether the total percentage that was or will be repaid on any loans made by the candidate to the terminating committee is comparable to the total percentage that was or will be paid to other creditors. 11 C.F.R. § 116.7(f)(1)-(6).

Application of the Six Factors. The Committee submitted information that supports its debt settlement plan. 11 C.F.R. § 116.7(f)(1). The supporting information must include the terms of the initial extension of credit and of the debt settlement, describe the efforts made by the Committee to satisfy the debt, and describe the remedies pursued by the creditor to obtain the payment on the debt. 11 C.F.R. § 116.7(e)(i)-(iii). As explained above, the Committee disclosed \$236,733.39 in debts owed to Dilworth Paxson LLP for legal fees and the Committee paid \$100,000 on that debt.¹ The Committee explained that it intended to pay off the remaining

¹ Commission regulations provide that a committee shall not make any payments in the debt settlement plan until completion of Commission review. 11 C.F.R. § 116.7(a). Here, the creditor has already agreed to accept the previous \$100,000 payment as the settlement amount. However, the regulation does not preclude the Commission from considering a debt settlement plan in which payment for the anticipated settlement has already

balance but that it “did not have sufficient funds.”² Attachment 1 at 6. The creditor stated that it has attempted to collect the debt through oral discussion and email correspondence. *Id.* at 7. The creditor has signed the debt settlement plan, confirming that it accepted the terms of the settlement, which the creditor stated were similar to the settlement terms of non-political debtors; namely, that invoices are due within 30 days, and that the creditor corresponded orally and through email with the Committee to work on payment and resolution of the billing issue. 11 C.F.R. §116.7(e)(2).

Regarding the second and third factors, the \$100,000 payment accounted for 57.76% of the total debt, leaving \$136,733.39 to be forgiven. *See* Attachment 2 and note 2, *supra*. The creditor law firm has accepted the \$100,000 payment, made in June 2018, as satisfaction of the full debt, initially incurred in April of the same year. Attachment 1 at 3, 6. 11 C.F.R. § 116.7(f)(2), (3). As to the fourth factor, the Committee has no cash on hand available and Brady has not been a candidate for election to federal office since January 2018. 11 C.F.R. § 116.7(f)(4).

The analysis of the Committee’s expenditures and receipts shows that the Committee spent \$18,927.76 year-to-date on utilities, service charges, and vehicle-related expenses, and received \$125.47 in dividends and interest. 11 C.F.R. § 116.7(f)(5). The Committee has disclosed \$8,555.74 in vehicle-related expenses between January 1, 2019 and June 13, 2019, which accounts for 45% of all expenses paid by the Committee this calendar year.

Given that former Representative Brady left office on January 3, 2019, the vehicle-related expenses raise the potential issue of whether campaign funds may have been converted to personal use. 52 U.S.C. § 30114; 11 C.F.R. § 113.1-113.2. Commission regulations, however, allow former officeholders to pay for the costs of winding down the office for a period of six months after leaving office. 11 C.F.R. § 113.2(a)(2); *see also* Contribution and Expenditure Limitations and Prohibitions: Personal Use of Campaign Funds, 60 Fed. Reg. 7862, 7873 (Feb. 9, 1995) (“this provision acts as a safe harbor”). All of the vehicle payments at issue here were made within six months of former Representative Brady leaving office and the payments stopped immediately after the six-month safe harbor period ended. The pattern of expenses, furthermore, was consistent with the vehicle expenses the Committee reported prior to his departure. *See* Attachment 3. The vehicle expenses thus may have been related to the winding down of his office. The Committee also reported the vehicle payments on its regular quarterly reports, none of which would trigger Reports Analysis Division thresholds for issuing an RFAI or a verification letter related to personal use of campaign funds.³ We thus conclude that these

² The amended Termination Report, filed on August 6, 2019, and the October Quarterly Report, filed on October 11, 2019, show no current cash-on-hand. The debt settlement plan filed by the Committee discloses the cash-on-hand as of April 1, 2019, which totaled \$8,931.83.

³ The Reports Analysis Division will send an RFAI to an authorized committee if a report contains one or more entries in excess of [REDACTED] each that are apparent per se personal use of campaign funds. Reports Analysis Division Review and Referral Procedures Standard 26. Vehicle expenses, however, are not considered per

considerations, taken together, should not prevent the Commission from approving the debt settlement plan. *See* 11 C.F.R. § 116.7(f)(5).

Finally, as to the sixth factor, the Committee neither owes any loans to any other creditor, nor to the candidate. 11 C.F.R. § 116.7(f)(6).

B. The Debt Settlement Plan Does Not Result In An Excessive Contribution To The Committee

We conclude that that the debt settlement plan meets the factors that the Commission considers when evaluating a debt settlement plan. 11 C.F.R. § 116.7(f). Because these factors have been met, we believe that the debt settlement with the law firm would not result in an excessive contribution from the law firm. *Id.*; *see Debts Owed By Candidates and Political Committees*, 55 Fed. Reg. 26378-26385 (Jun. 27, 1990). We, therefore, recommend that the Commission approve the debt settlement plan.

se personal use under Commission regulations. *See* 11 C.F.R. § 113.1(g)(1). Further, because Brady served as an officeholder during the previous two-year election cycle for the U.S. House of Representatives, the Committee is not a “dormant committee” and thus would not have received a verification letter from the Reports Analysis Division that would seek clarification of the reported vehicle expenses.

IV. RECOMMENDATIONS

1. Approve the debt settlement plan filed by Bob Brady for Congress;
2. Approve the appropriate letter; and
3. Close the file.

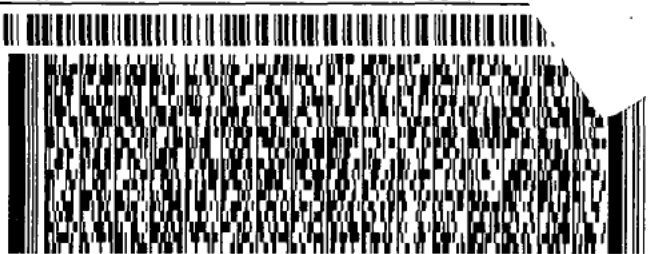

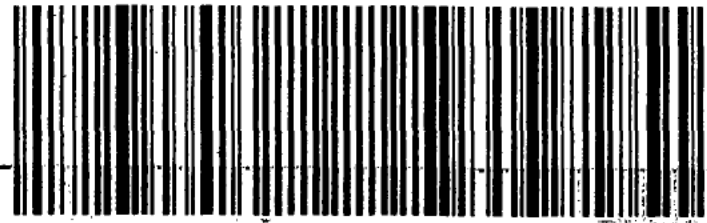
