Definitions

- Title 2** The audit was authorized under Title 2 of the US Code §438(b) which permits the Commission to conduct audits and field investigations of any political committee that is required to file a report under 2 U.S.C. §434.
- Title 26** The audit was mandated by Section 9038(a) of Title 26 of the United States Code. That section states “After each matching payment period, the Commission shall conduct a thorough examination and audit of the qualified campaign expenses of every candidate and his authorized committees who received [matching] payments under section 9037.”
OR
The audit was mandated by Section 9007(a) of Title 26 of the United States Code. That section states that in the case of publicly financed campaigns, “after each presidential election, the Commission shall conduct a thorough examination and audit of the qualified campaign expenses of the candidates of each political party for President and Vice President.”
OR
The audit was mandated by mandated by Section 9008(g) of Title 26 of the United States Code. That section directs the Commission to conduct an examination and audit of the payments for presidential nominating conventions.
- Authorized** The Committee audited was a principal campaign committee or other political committee authorized by a non-Presidential candidate.
- Unauthorized** The Committee audited was not authorized by any candidate, such as a Political Action Committee (PAC) or a party committee.
